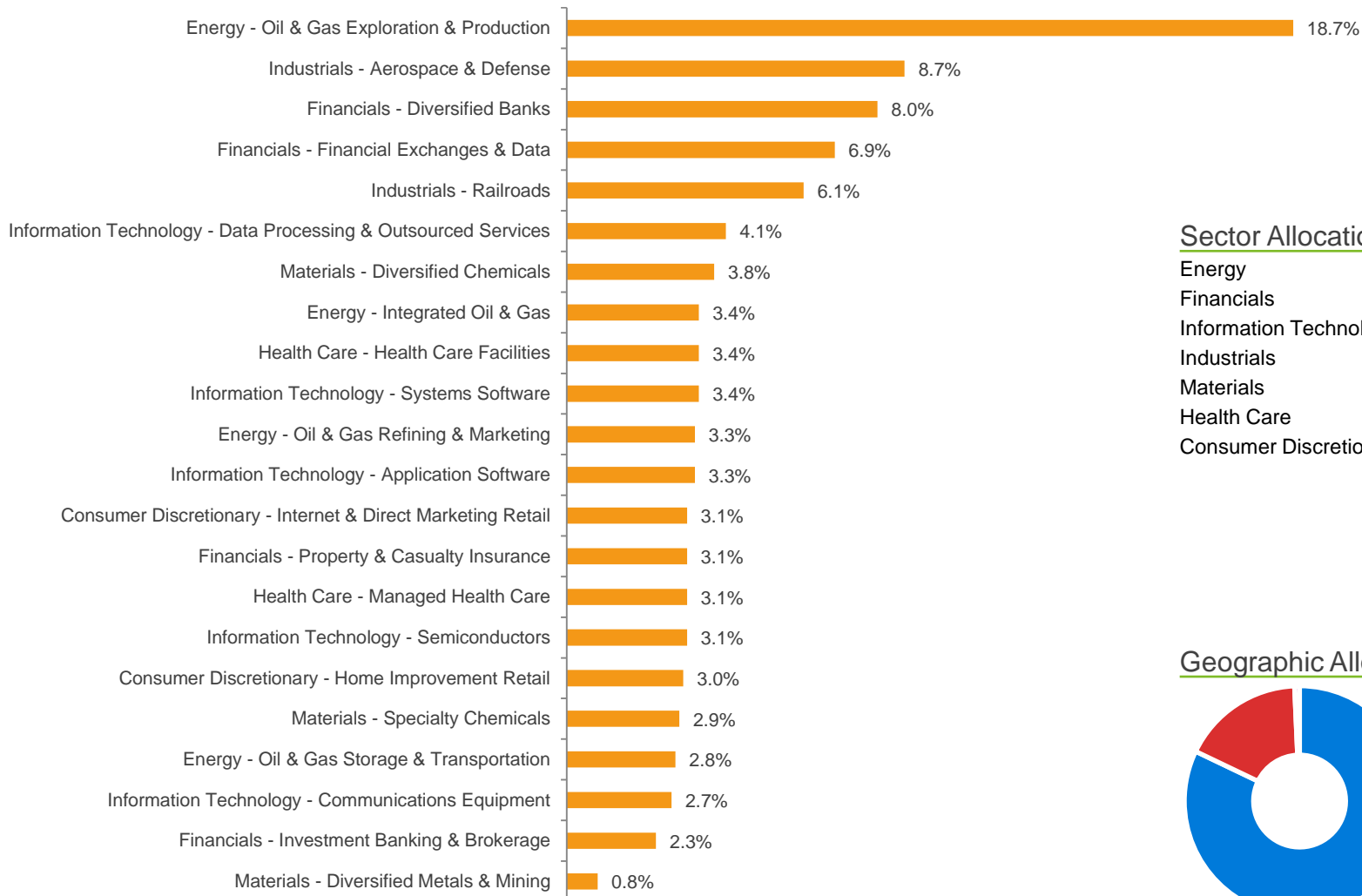

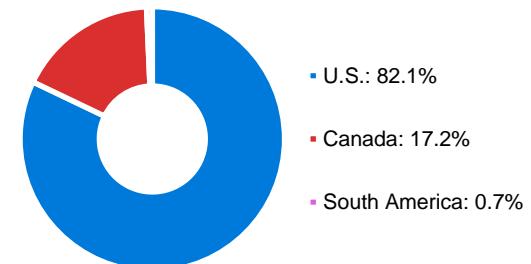
Industry Allocations as at June 11, 2018
