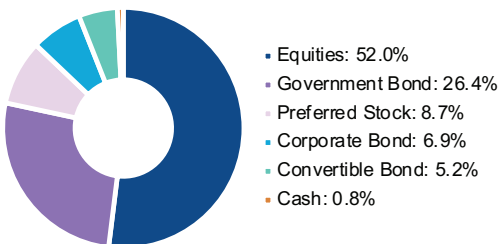

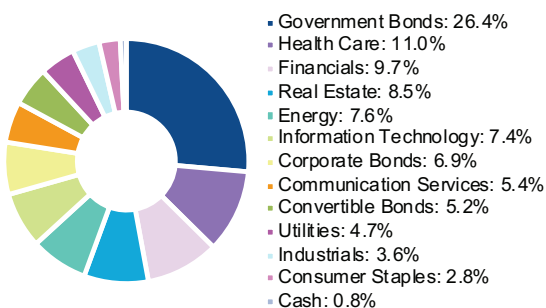

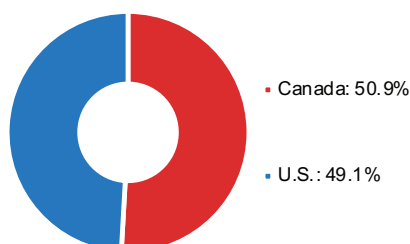
Asset Allocation
